Subject: Grant of recognition to the school from class 1st to X (without aid) w.e.f. academic session 1985-87 for a day school (Single shift).

Sir,

With reference to your application on the subject cited above, I am directed to grant recognition to your school from class 1st to Xth (without aid) w.e.f. 1985-87 subject to the fulfilment of the following terms & conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act & Rules framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed and preference shall be given to the students of Priyadarshini Vihar.
3. That the school shall appoint full time qualified and eligible staff for all classes of the school as per the present norms of the Department.
4. That the school shall ~~xxxxxxx~~ equip the Science lab, as per the norms of the Department and suitable facilities for practical work shall be provided to the students.
5. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per students may be added and facilities of reading room may also be provided immediately.

6. That adequate sports materials shall be purchased and made available to the students immediately.
7. That the school shall strictly abide by the provisions of Sec.10(i) of Delhi School Education Act & Rules, 1973.
8. That the enrolment in each section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the classroom and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi in each class. Number of existing sections should not be exceed the number of classrooms of proper size in the school.
9. That the school shall not run any pre-primary and unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place. Nursery class be removed from the premises of the school, if any. No Branch of this school shall be run under the banner of the recognised school.
10. That the school shall dispense with the services of unqualified & overaged staff, if any, immediately.
11. That service contract between the management and the employees shall be executed immediately.
12. That all the facilities prescribed under Rule 50 and 51 of the DSER, 1973 shall be made available to the students. Provision of Rules 6, 7 and 9 be strictly observed.
13. That the arrangements for good drinking water shall be made available to all the students as well as to teachers and sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the local body within a month.
14. That the management of the school shall create a reserve fund of Rs.15,000/- (Rupees Fifteen thousand only) in a joint account in the name of the Director of Education and the Manager of the school in any scheduled bank within a month.
15. That the violation of any instruction/orders/conditions/rules and regulations of the Department shall lead to the withdrawal of recognition of the school. That class XIth shall not be added to the school without the prior permission of the Director of Education, Delhi.

16. That no development fee shall be charged from the students.
17. That a report about the fulfilment of the above conditions, giving the extent to which each condition is fulfilled shall be sent to the Education Officer every six month.

Sir,

With reference to your application on the subject  
cited above, I am directed to convey the approval of the  
Director of Education, Delhi for the upgradation of the  
existing Secondary school to Sr. Sec. level with effect from  
1987-88 session subject to the fulfilment of the following  
terms and conditions:-

1. That the school shall abide by the provisions of Delhi  
School Education Act and Rules framed thereunder as  
well as the instructions issued from time to time.
2. That the school shall admit students without any  
discrimination of caste and creed.
3. That the school will meet the additional liability  
of Sr. Secondary classes.
4. That the school shall establish and equip all the  
three Science Lab. as per norms of the department and  
CBSE. Suitable facilities for practical work shall be  
provided to the students.
5. That a proper library shall be established and facilities  
for reading room shall also be made available for  
students as well as teachers. Books as per the ratio of  
10 books per student may be added and 500 more approved  
books may be purchased.
6. That adequate sports material shall be purchased and  
made available to the students immediately.
7. That the school shall strictly abide by the provisions  
of Sec. 10(i) of the Delhi School Education Act & Rules  
1973 and payment shall be made through crossed cheque.  
and arrear in respect of IR may be made within a month  
to the staff under intimation to the Education Officer  
by 31st Oct., 1986.

8. That the enrolment of each section shall not exceed the number of students calculated @12 sq.ft. per student for the available floor area of the class-room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, in each class. Number of sections should not exceed the number of existing class-rooms of proper size in the school and each class room, Science Lab. and library rooms may be fitted with Electrical fans.
9. That the school shall not run any unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the above address only. Nursery classes be removed from the premises of the school immediately.
10. That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately.
11. That the service contract between the management and the employee shall be executed immediately.
12. That all the facilities prescribed under rule 50 and 51 of the DSER, 1973 shall be made available to the students.
13. That the arrangements for good drinking water shall be available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the Local Body within a month.
14. That the management of the school shall create a reserve fund of Rs.15000/- (Rupees fifteen thousand only) and condition No.15 of the previous letter may also be fulfilled and new total reserve fund of Rs.30,000/- may be deposited in a Joint Account of DE and Manager of the school.
15. That the violation of any instructions/orders/conditions/rules and regulations of the department shall lead to the withdrawal of recognition of the school.
16. That the Nursery classes will not run in the building occupied by the school.

17. That the report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled shall be sent to Education Officer every six month and a report about the payment of interim relief shall be sent by the 10th Nov., 1986 to the E.O.
